Gene provided the fire chief's report-

- The fire district responded to two fires (a car fire and a large wild land fire) and four aid calls last month.
- Gene has started building our new water tender. We are waiting for a Monitor to install on the tender. A monitor is a device installed on top of the tender that allows a high pressure water discharge to be controlled from the cab of the tender. Further updates will provided at our next meeting.
- Four vehicles have been serviced and are ready for this season. Other vehicles are scheduled for service. Gene will provide an update at our next meeting.

- Gene will decommission our two ambulances. Our new 4x4 rescue truck (R-1611) will replace the ambulances.
- Gene reports that he expects power to be installed at our fire station this week.

Old Business-

- Mike and Gene will meet to discuss our budget and establish priorities. They will report back at our next meeting.
- Mike has been researching options for a memorial for fire fighters that have died. Mike expects he will have a final plan to present at our next meeting.
- Additional storage discussions were tabled until our next meeting.
- Mike has started to address the State Audit information request. His goal is to have the information completed by next week.

New business-

New training equipment for the fire station was discussed. A multi-function printer, an internet
router, a TV and sound system and tables or desks were discussed. Mike will purchase the printer
within the next few weeks. Discussions on the remainder of the equipment will be tabled until our
next meeting.
