A Contract for Reimbursement of Costs Using POV for District Business was signed by the commissioners and fire chief Gene Jones.

 Mike provided a training room and security update for the fire hall. Additional actions will be determined at our next commissioners meeting.

## New business-

- Gene informed the commissioners our medical AED's have been recalled. It was determined we will wait until the details of the recall and actions required are provided by the manufacturer.
- Insurance for our EMT's was discussed. Additional information is being collected and will help determine our next actions.
- An agreement with DNR was discussed and approved. The agreement was signed by the commissioners.
