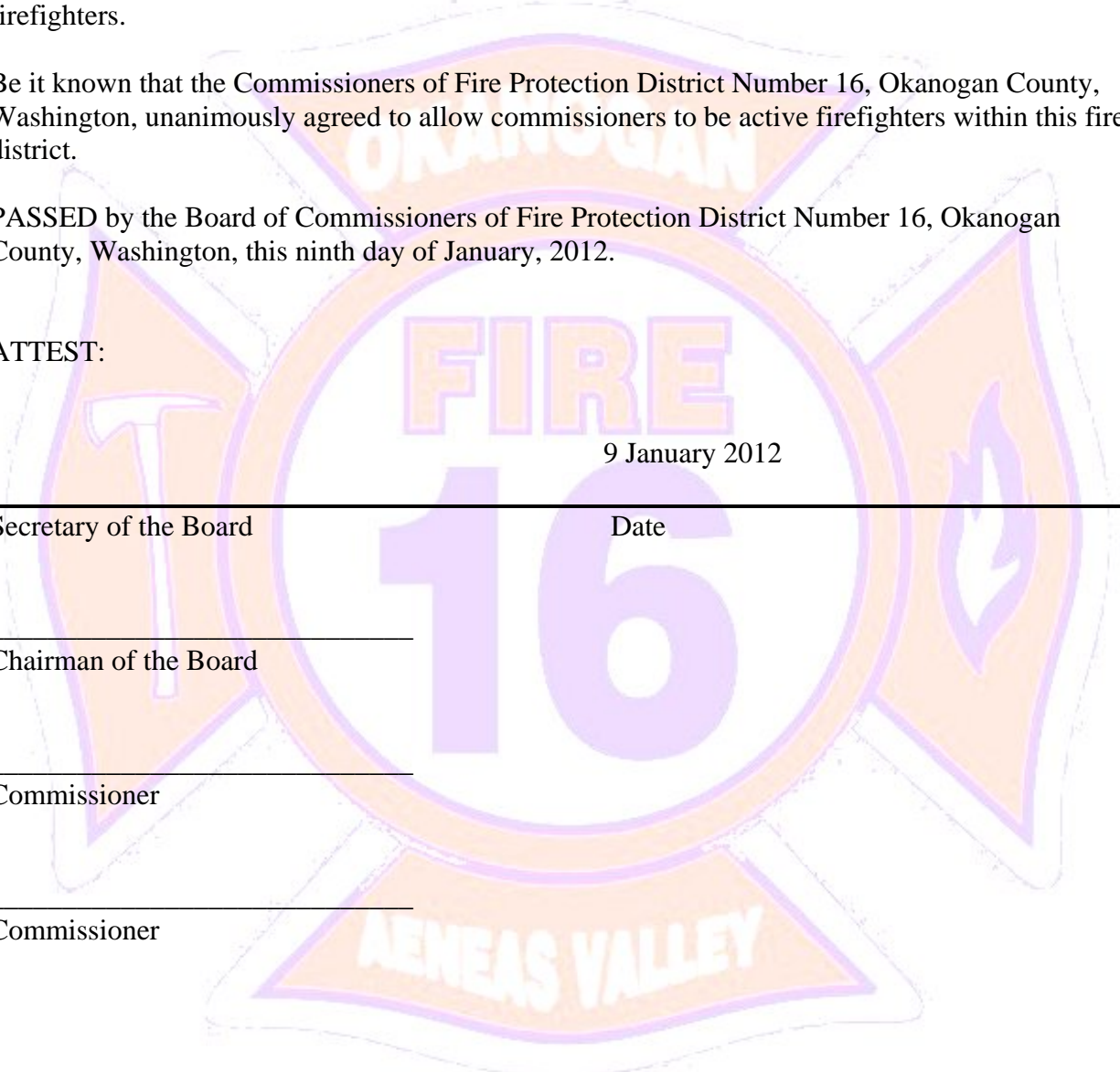

Whereas, to meet financial obligations of the above district, a budget was created and resolved at an open public hearing on November 12, 2012.

Be it further resolved, that copies of this resolution, and copies of the budget document, be sent to the Okanogan County Treasurer and the Okanogan County Auditor.

Furthermore, copies of the budget are posted within the Fire District, in a public place, as well as publishing said document in the County's newspaper of record.

Be it also known that the Fire District wishes to continue with the maximum levee rate possible, up to one dollar per thousand of tax value, tempered only by the 101% rule.
